**STIPULATED ORDER**

Plaintiff Nuclear Watch New Mexico, and Defendant DOE (Department of Energy) /NNSA (National Nuclear Security Administration), hereby stipulate as follows regarding production of future site plans and exemptions applied to future site plans:

1. NNSA will post each TYSP (Ten Year Site Plan) on its website within 60 days after each TYSP is accepted by NNSA Headquarters. This applies only to requests for future site plans beginning with FY 2009, and not to site plans previously requested. Any and all redactions made to the Site Plans published on the web or otherwise provided in response to any specific FOIA request for such records will be clearly identified with appropriate references to the FOIA exemption or exemptions relied upon as the justification for any such redactions, as required under the FOIA.
2. NNSA will aim to provide site plans without any redactions. Redactions, if any, in the site plans will follow the procedure in the NNSA April 11<sup>th</sup>, 2008 Guidelines (attached as Exhibit 1 to Doc. 73), thereby applying FOIA exemptions to the site

plans, uniformly and consistently, from site-to-site and year-to-year, with the added oversight of the Site Offices from both the NNSA Service Center FOIA Office and the NNSA Office of Chief Counsel.

3. NNSA has re-reviewed the Y-12 FY 2008 Site Plan, and the entire Site Plan including de-redacted pages was mailed to Plaintiff's counsel on June 12, 2008.
