The National Nuclear Security Administration (NNSA) Headquarters has completed its review of the Fiscal Year (FY) 2013-2037 Twenty Five Year Site Plans (TYSPs) for the NNSA Field Offices and the Office of Secure Transportation. Your FY 2013-2037 TYSPs are accepted. Please extend our sincere appreciation and gratitude to all who have participated and collaborated in developing this year's Plans.

This year's TYSPs were well done and aligned with the Program of Record including the President's FY 2013 budget, the FY 2012 Stockpile Stewardship Management Plan (SSMP) goals and direction, the 2010 Nuclear Posture Review, and the Records of Decisions. These TYSPs are planning documents and do not necessarily reflect final decisions. We are reviewing the guidance for the FY 2014 TYSPs to identify any changes. The most significant change is moving from a 25-year plan to a 10-year plan.

Due to the frequent requests for the TYSPs under Freedom of Information Act (FOIA) and to promote transparency and openness in Government, the FY 2013-2037 plans will be made available to the public. The TYSPs are also available publicly in accordance with the Stipulated Order in the case of Nuclear Watch New Mexico v. DOE/NNSA, Civil No. 06-221 BB/WPL. Your plans will be posted to a public web site within 60 days of the acceptance date on this memorandum.
