The following table shows the history of LANS's and DOE's requests for extensions of deadlines for the 16 violations which NWNM cited in its MSJ. In each case, the operative language of the requesting parties is quoted, together with a URL link to the original document. For the great majority of cases, LANS and DOE used identical request language, explicitly stating that the request was based on the provisions of the 2005 CO: "The U.S. Department of Energy and Los Alamos National Security, LLC, (DOE/LANS) request this extension under Section III.J.2 of the March 2005 Compliance Order on Consent."
